It is here by informed to all the concerned that, as per the decision of the Standing Committee of the Academic Senate Vide Letter No.300/Acad.I/2024, dated: 02.04.2024, the students of UG (CBCS) B.A/B.Com/B.Sc/BBA/BSW Semester I to VI Course who were admitted in the academic year 2016 -2017, 2017-2018 and 2018-2019 are permitted to clear their backlog papers after the stipulated period (i.e. within five years (3+2)) by appearing in the ensuing examinations with a penal fee of Rs.2,000/- per paper in addition to normal exam fee, as a one-time chance. The exams will be conducted tentatively in the month of May, 2024.

 The results of ineligible candidates will be cancelled at any stage, even if they write the examination.".

- 1. The detail of Examination Fee schedule is enclosed.
- 2. Tentatively the examinations would be conducted in the month of May, 2024. The exact date of commencement of the Examinations and detailed time table would be notified in due course of time.
- 3. The Exam fee is exempted for students with physical disability, Visual and Hearing impairment, as per the O.U Order No. 1555/228/2007-08/Budget-V, dated: 25-03-2008. A Xerox Copy of Medical Certificate confirming their status as Physically challenged / Visually impaired or Hearing impaired (minimum percentage of disability must be of 40%) must be attached to the Application forms. Physically challenged / Visually impaired or Hearing impaired Students application forms should be submitted separately along with Separate Nominal Roll.
 - a) Inform all the concerned candidates that the payment of examination fee & submission of application forms will not be entertained after the due date <u>under any circumstances</u>. The Examination fee once paid by the candidate will not be refunded adjusted/re-adjusted under any circumstances.
 - b) Prepare separate nominal rolls for Other courses & Honor's students.
- Consolidated fee receipt obtained from the SBI Bank may be submitted to the Deputy Registrar, (Cheque-II)
 <u>Section, Examination Branch, OU where receipts pertaining to B.A./B.Com.,/B.Sc.,/B.B.A./B.S.W.</u> will be issued
 separately. (In no case individual receipts submitted students will be accepted).
 - (a) <u>Fees Abstract</u>: Submit one hard copy of the Fee Abstract prepared/downloaded using the link provided at college login.
 - (b) Fee Receipt Issued by the Deputy Registrar, Cheque-II Section, Examination Branch, OU.
